

## Reservation Information

► Reservations are taken for a minimum 2 night stay, except holidays which require a minimum 3 night stay.

► If your reservation is made 14 days or more prior to your stay, the required payment is due within 10 days of making the reservation.

► If your reservation is made less than 14 days prior to your stay, the required payment is due immediately upon making the reservation.



## Camping Information

► One major camping unit is allowed per site (An additional small tent, no larger than 50 sq. ft. is also permitted).

► A site may be occupied by only 1 family (no more than 6 people), or 1 group (no more than 4 people).

► Campsites may only be registered by a person 18 years or older and who is staying on the site.

► **Check-Out: 1:00 p.m. Check-In: 3:00 p.m.**

► Campsites #1 through #22 at Coldwater Lake Family Park may not be occupied for more than 14 days at a time. At the end of the 14 days, the camping unit must be taken off and moved to another site (other than 1-22) for a minimum of 2 nights or removed from the park.

► **Park Entrance Permit (PEP):** A PEP for your vehicle is included with your reservation. Additional motor vehicles may enter with the purchase of a Daily or Annual Pass. All permits and passes must be properly affixed on the inside of the vehicle (driver's side) windshield.

► **Cabin Key Deposit:** \$10 deposit which is refunded upon return of the cabin key.

## Camping Refund Policy

All refunds are processed at Park Headquarters and are subject to the following conditions:

► If cancellation is received at least 5 days prior to beginning of stay, the refund will be the amount paid less a \$15 cancellation processing charge.

► If cancellation is received less than 5 days prior to beginning of stay, the refund will be the amount paid less \$15 cancellation processing charge and 1 night camping fee.

► Once occupied, a refund for a campsite (that has been reserved in advance) will only be made for 5 or more nights, less any minimum stay requirements. For less than 5 nights, a credit towards future camping will be provided for each night cancelled, less minimum stay requirements.

► Cancellation of all or portion of a campground visit may be made by mail, telephone or in person. Cancellations may not be made by email. Failure to notify of cancellation in a timely manner may result in partial or full forfeiture of camping fees paid.

► Refunds/credits for discounted (monthly) rates for sites occupied and vacated early are calculated in the following manner: A cancellation fee of \$50 is charged for each cancelled 30 consecutive night reservation up to March 31. Cancellations made after this date and at least 30 days from the beginning of your stay will be charged the \$50 fee plus half of the reservation charge. There are no refunds for cancellations after this time.

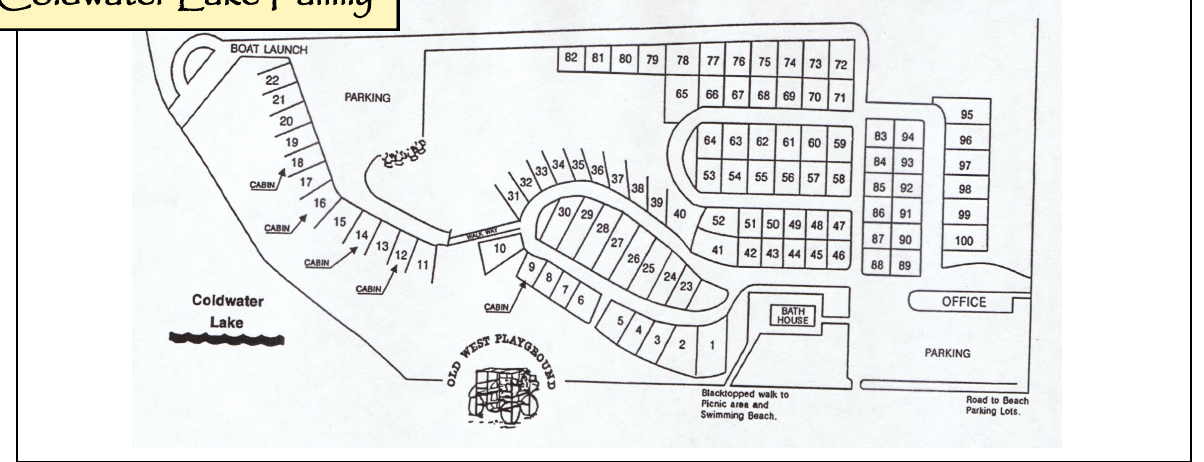

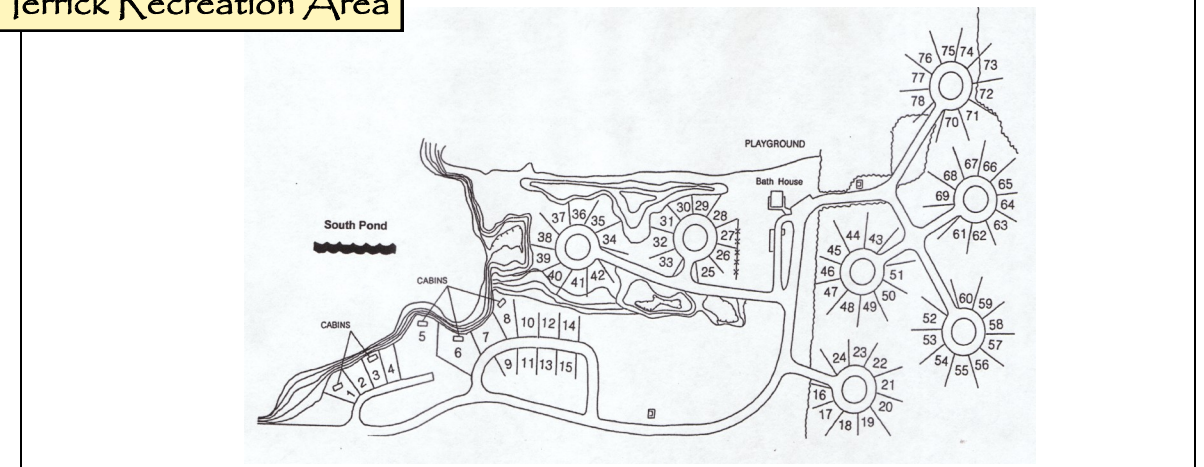
