Giving to the Isabella County Commission on Aging Endowed Fund is giving to the care of the Elders in our community. It allows you to give a generous gift that will have a lasting effect on the services received by the Elders in our county.

How it works

- You can make a bequest to the Isabella County Commission on Aging (I C C O A) Endowed Fund through your will and estate. You can decide to do it at any age by adding to an existing will or drafting a new one. In doing so you leave a legacy to the ICCOA and your community, while enjoying the assets you need to maintain your current lifestyle. Plus, you are able to distribute some or all of your assets, tax free.
- You can give a gift of cash, appreciated stocks, real estate or other assets. Some of the most tax-efficient asset types to give through your will come from retirement plan accounts, since heirs would be taxed on the income in respect of the decedent (IRD). You can choose to give a stated dollar amount, a specific property, a percentage of your estate, the remainder after distributions to other beneficiaries, or you can make your gift contingent on certain events.
- Your gift will be placed into the ICCOA Endowment and will be invested over time. Earnings from the endowment are used to address the needs of Older Adults throughout Isabella County. Your gift is a permanent source of community capital, helping to do good work forever at the Commission on Aging.
- The Mt. Pleasant Area Community Foundation handles all the administrative details. They can work with you, your family and even your financial advisor to find the right answers.

Plus we provide support to many isolated and special needs Elders with our Senior Companion Program. For those Older Adults who are able to be active in the community we have our Congregate Meals sites and our Senior Center which provides many activities and a Travel Program. With all of these services we still have the heart of our programs, which is represented by hundreds of volunteers through our Gold Key Volunteer Program. Our volunteers enable us to expand our services and care, which helps us to better answer the needs of Older Adults in a dignified manner.

The Isabella County Commission on Aging has developed into a leading multi-service agency that provides a community focal point for the needs of our Older Adult population and their families.
