#### **Finance and Administration Committee:**

# 1. Invoice Lists: October 12, 2018 Invoice List; October 18, 2018 Invoice List; October 26, 2018 Invoice List; and the November 1, 2018 Adjustment List:

It was moved by Commissioner Horton and seconded by Commissioner Ling to ratify and place on file the October 12, 2018 Invoice List in the amount of \$778,566.68, the October 18, 2018 Invoice List in the amount of \$171,580.82, and the Adjustment List dated November 1, 2018. # 2. Resolution No, 18-11-03, USDA Loan New Road Commission Facility

**WHEREAS**, on March 6, 2018, the County of Isabella ("the County") adopted a resolution declaring its intent to issue its bonds in one or more series (collectively, the "Bonds") to finance the cost of acquiring, constructing, improving, equipping and furnishing new Isabella County Road Commission facilities to be located in the County, demolishing certain existing Isabella County Road Commission facilities and making improvements to the sites of the new and existing facilities; and

**WHEREAS**, a notice of intent to issue the Bonds was published in the *Morning Sun* on March 10, 2018 in accordance with the requirements of section 517 of Act No. 34, Public Acts of Michigan, 2001, as amended; and

**WHEREAS**, the Board has determined to pursue financing through the United States Department of Agriculture, Rural Development ("Rural Development") in furtherance of Rural Development's program to provide low-interest rate, long-term loans for eligible projects.

**BE IT RESOLVED** by the Board of Commissioners of the County of Isabella, Michigan, as follows: Each of the Chairperson of the Board and the County Administrator/Controller is authorized to execute the Rural Development application and related documents on behalf of the County in anticipation of the sale of the Bonds to Rural Development.

All resolutions and parts of resolutions insofar as they may be in conflict herewith are hereby rescinded.

It was moved by Commissioner Ling and seconded by Commissioner Horton to adopt Isabella County board of Commissioners Resolution No, 18-11-03, approving the SF424 Application and standard application certification forms for the USDA loan for the new Road Commission facility, and authorize the Board chair to sign the same. The motion carried with 7 yeas and 0 nays. Yeas: Commissioners Green, Engler, Jaloszynski, Horton, Moreno, Ling, and Hope. Nays: None.

# 3. FY 2019 MSUE Agreement:

It was moved by Commissioner Horton and seconded by Commissioner Ling to approve the Agreement for Extension Services between Isabella County and Michigan State University Extension (MSUE), effective October 1, 2018 until September 30, 2019, in the amount of \$154,118.00, and authorize the Board Chair to sign the same. The motion carried with 7 yeas and 0 nays. Yeas: Commissioners Green, Engler, Jaloszynski, Horton, Moreno, Ling, and Hope. Nays: None.

4. Drain Commission USDA/NRCS 25% Match Loan: Removed from the agenda.

# 5. Resolution No, 18-11-01, Public Act 152:

**WHEREAS**, Public Act 152 of 2011 was passed by the Legislature and signed by the Governor on September 24, 2011; and

WHEREAS, the Act contains three options for complying with the requirements of the Act; and

WHEREAS, Isabella County has elected to exempt itself, since the enactment of the Act; and WHEREAS, Section 8 of the act permits a qualifying unit of local government to exempt itself for the provisions of Section 3 and Section 4 for the next succeeding year by a 2/3 vote of its governing body, prior to the start of the benefit year;

**NOW THEREFORE BE IT RESOLVED**, that effective November 6, 2018, the Board of Commissioners of Isabella County elects to comply with the requirements of Public Act 152 by adopting the annual Exemption option for the medical benefit plan coverage year January 1, 2019 through December 31, 2019.

It was moved by Commissioner Ling and seconded by Commissioner Horton to consider adopting Resolution No, 18-11-01, by a 2/3 vote of the Board of Commissioners, to exempt Isabella County from the requirements of Public Act 152 for calendar/benefit year of 2019 and authorize the Board Chair to sign the same. The motion carried with 7 yeas and 0 nays. Yeas: Commissioners Green, Engler, Jaloszynski, Horton, Moreno, Ling, and Hope. Nays: None.

# **Criminal Justice and County Affairs Committee:**

#### 1. Sheriff's Office Transport Officers:

It was moved by Commissioner Jaloszynski and seconded by Commissioner Engler to approve the hiring of up to 5 Transport Officers at the Isabella county Sheriff's Office as Casual, call-in, part time staff to work up to 29 hours per week at a starting pay of \$16.00 per hour and these fringes required by law, FICA and worker's compensation. The motion carried with 7 yeas and 0 nays. Yeas: Commissioners Green, Engler, Jaloszynski, Horton, Moreno, Ling, and Hope. Nays: None.

#### 2. FY 2019 Community Corrections Grant:

It was moved by Commissioner Engler and seconded by Commissioner Jaloszynski to approve the FY 2019 Community Corrections Grant in the amount of \$128,120.00, and authorize the Board chair to sign the same. ## 3. FY 2019 Juvenile Drug Court Grant Program Contract:

It was moved by Commissioner Jaloszynski and seconded by Commissioner Engler to approve the Juvenile Drug Court Grant Program FY 2019 Contract, in the amount of \$108,000.00, and authorize the Board Chair to sign the same. The motion carried with 7 yeas and 0 nays. Yeas: Commissioners Green, Engler, Jaloszynski, Horton, Moreno, Ling, and Hope. Nays: None.

#### 4. FY 2019 Swift and Sure Sanctions Probation Program Contract:

It was moved by Commissioner Engler and seconded by Commissioner Jaloszynski to approve the Swift and Sure Sanctions Probation Program FY 2019 Contract, in the amount of \$210,000.00, and authorize the Board Chair to sign the same. #### 5. FY 2019 Adult Drug Court Grant Program Contract:

It was moved by Commissioner Jaloszynski and seconded by Commissioner Engler to approve the Adult Drug Court Grant Program FY 2019 Contract, in the amount of \$77,000.00, and authorize the Board Chair to sign the same. **WHEREAS**, through insurance coverage from USA Cycling, Isabella County Commission Board Members and employees shall be indemnified from all claims, suits, and judgments; and

**NOW THEREFORE BE IT RESOLVED** that on November 6, 2018, the Mid-Michigan Cycling Club will host a bicycling event on the 1<sup>st</sup> day of December, 2018 at the Isabella County Deerfield Nature Park.
