SPR#17-05 – Barkman Apiaries LLC – Sherman Township

Mr. Johnson stated that an application was received by Mr. Daniel Jost. The applicant is modifying a previously approved site plan. Please recall from the November 2016 Planning Commission meeting, Barkman Apiaries was approved for a special use permit to include agricultural labor housing on their farm in Sherman Township. The site plan approved at that time included 4 units for labor housing attached to the main building.

Mr. Johnson informed the board that Daniel Jost is requesting a re-design of the agricultural labor housing. The current proposal before you includes an 80 x 86 ft area north of the new building in which 4 mobile homes would be installed for the agricultural labor housing.

Mr. Johnson explained that the "shop" building being proposed with a setback of 71 feet where previously it was proposed to be at 264 ft from the front lot line. This new building also appears to meet all setback and dimensional requirements of the ordinance.

Board discussion took place.

A motion was made by Mr. Murphy supported by Mr. Gilchrist approve Site Plan Review 17-05 (SPR#17-05) which was submitted by Daniel Jost of Barkman Apiaries with the stipulation the applicant provide a copy of a well and septic permit from the Central Michigan District Health Department.
