## **NEW BUSINESS**

# Variance #16-11 – Edward Pappas – Vernon Township

Mr. Johnson in formed the Board that an application was filed in December by Edward Pappas and included a site plan, photos of the property and written justification for the variance

application. The applicant is requesting a variance to allow for a newly created parcel be 6.5 acres in size where a maximum size of 3 acres is allowed.

Mr. Johnson explained from the site plan Mr. Pappas desires to split the home and outbuildings from the adjoining farm field to create a 6.5 acre parcel. Section 5.06 B. limits the size of a newly created parcel to be 3 acres in area when comprised of 75% or more of the identified major agricultural soils. Mr. Pappas' property is comprised of 77% identified major agricultural soils, thus the need to obtain a variance to split the property as desired.

Tim Beebe spoke on behalf for Mr. Pappas. Stating the driveway location is placed in its current location for safety reasons which are caused by the overpass.

Mr. Nieporte asked if the property west of the parcel was wet.

Mr. Pappas stated yes the run off from the overpass contributes to wetness.

A motion was made by Mr. Duffett seconded by Mrs. Fosburg to approve Variance Number 16-11 (VAR#16-11) which was submitted by Edward Pappas for a newly created parcel to be 6.5 acres in size where a maximum of 3acres is permitted for this parcel in the Restrictive Agricultural (AG-1) District. The approval is based upon the following that it meets the criteria stated in section 14.04 C of the Isabella County Zoning ordinance.
