Finance and Administration Committee:

1. March 9, 2016 Claims List and March 16, 2016 Claims List:

It was moved by Commissioner Horton and seconded by Commissioner Ling to ratify and place on file the March 9, 2016 Claims List in the amount of \$75,295.00, the March 16, 2016 Claims List in the amount of \$53,081.12 and the March 23, 2016 Claims List in the amount of \$127,266.04. 1. Out of State Travel – Midwest Crisis Negotiators Conference:

It was moved by Commissioner Haupt and seconded by Commissioner Jaloszynski to authorize the out-of-state travel for Detective Dave Patterson to attend the Midwest Crisis Negotiators Conference in Columbus, Ohio, in the amount of \$1,266.00. Commissioner Horton asked how often Detective Patterson has been called to a negotiation situation. Sheriff Michael Main explained that the negotiation team gets called out a few times per year. 2. 2016 Youth and Farm Fair:

It was moved by Commissioner Haupt and seconded by Commissioner Jaloszynski to approve the Agreement between Isabella County Sheriff's Department and Isabella County Youth and Farm Fair to provide security services for the 2016 Youth and Farm Fair, and authorize the Board Chair to sign the same. 1. Memorial Forest Recreation Area Lease:

It was moved by Commissioner Jaloszynski and seconded by Commissioner Haupt to approve the Memorial Forest Recreation Area Lease Agreement between Mount Pleasant Schools and Isabella County for a three-year period, and authorize the Board Chairperson to sign the same. 2. Wise Township Playground Lease:

It was moved by Commissioner Jaloszynski and seconded by Commissioner Haupt to approve the Wise Township Playground Lease Agreement between Wise Township and Isabella County for a three-year period, and authorize the Board Chair to sign the same. The motion carried with 5 yeas and 0 nays. Yeas: Commissioners Green, Haupt, Jaloszynski, Horton, and Ling. Nays: None.
