The Isabella County Board of Commissioners was called to order at 7:00 p.m., by Chairperson George Green in the Commission Chambers on the above date.

APPROVAL OF AGENDA:

PUBLIC HEARING ON THE ISABELLA COUNTY 2007 HAZARD MITIGATION PLAN UPDATE: Chairperson Green opened the public hearing at 7:05 p.m.

Emergency Manager McCarther Griffis reviewed the 2007 Hazard Mitigation Plan update. The updated plan will be forwarded to the State of Michigan and then to FEMA for comment. The document will then return to Isabella County formal approval. The Hazard Mitigation Plan works to identify pre-mitigation or pre-disaster issues in the County. Examples are loss of life and destruction of property due to natural disasters.

1. Swift and Sure Sanctions Probation Program:

1. CMU Mobile Recreation Unity Agreement:

2. Modification 2 to Restatement of the Interlocal Agreement:

It was moved by Commissioner Moreno and seconded by Commissioner Haupt to enter into Modification 2 of the Restatement of the Interlocal Agreement dated June 28, 1983, as amended, establishing the Saginaw County/Midland County/Bay County Job Training Partnership Act Consortium to extend the end date of the temporary agreement 6 months, from June 30, 2016 to December 31, 2016 and authorize the Board Chairperson to sign the same.
