**1. Welcome & Introduction of New Members**

The meeting was called to order by Laura Gonzales, Committee Chair at 5:00 p.m. Committee members and guests were welcomed by her. Anne Swift (At-Large Representative), the newest HRC member, was introduced to the committee.

**2. Approval of Agenda:**

The motion to approve the agenda, as presented, was made by Jeannie Jackson and seconded by Maureen Eke. The motion was unanimously supported by the committee members.

**3. Public Comments:**

No public comments were presented at tonight's meeting; although there were three guests in the audience.

**4. Guest Speaker: Sheriff Leo Mioduszewski**

Jail staff can provide most of the information requested, with the exception of marital status, recidivism, and number of children. The Sheriff requested that we complete a FOIA form to cover the release of the requested information. Laura Gonzales will complete the form (on 8/07/12), which can be procured from the Jail office. The requested data will be provided as soon as the FOIA form has been completed; a date range is needed for requested date. The force is made up of 19 officers, 14 deputies and 5 other officers. There are no officers of color on the Sheriff's Department. More than 50% of the Corrections Officers are female; however there is only one female deputy. Youth outreach happened through the Youth Services Officers program, which is no longer a funded program. Youth Citizens Academy is a two-week summer program for youth interested in police services. Job openings are advertised in the Morning Sun, County Website, Statewide Sheriff's website and occasionally in the Detroit paper. Department funding is primarily County general funds, and supplemented through grant funds. Beal City School reports a 19% increase in incidents of bullying since the police have been removed from the school. 56% of inmates from January 1, 2012 are county residents. The Jail is moving to a new system for visitation and will be using a video-conferencing system, similar to Skype; visitation will still be available face to face. Department policy is that Officers have business cards and they hand them out freely at crime scenes, and at other community functions. Department policy is that Officers, "will call-out at every traffic stop"; and let Dispatch know that they are stopping a vehicle. Officers that visit a home typically introduce themselves and request permission to enter or speak with the individual. Laura will also drop rack cards off at the Jail. An offer for a tour of the jail was made, for any HRC members who are interested.

## 5. Approval of Minutes of July 9, 2012 Meeting:

A motion to accept the minutes as corrected (add Amy Shawboose's name to members present) was made by Susan Poindexter and seconded by Jeannie Jackson. The motion was unanimously supported by the committee members.

## 6. Old Business:

A Tribal Council Liaison, Frank Cloutier, has been established and a timeline has been established. Amy Shawboose will send a copy of the established timeline and budget to the members this week.

Laura has completed a draft of the letter to be submitted to the City Manager, once the letter has been reviewed by the officers. No paperwork has been received from the complainant.

Elizabeth Husbands will be working to decorate the showcase as soon as the Ziibiwing Cultural Center staff is available to assist by the provision of items for the showcase.
