D. Collective Bargaining Agreement Offer to Command Officers Association of Michigan – Command Unit:

It was moved by Commissioner Hope and seconded by Commissioner Jaloszynski to enter into a 3-year agreement between Isabella County Board of Commissioners and Isabella County Sheriff's Office and Command Officers Association of Michigan – Command Unit, agreeing that 2% shall be added to the 2020 base wage scale, effective January 1, 2021, with a wage reopener for years 2022 and 2023, and to include the language in the Employer's package offer to settled dated March 15, 2021. The motion carried with 7 yeas and 0 nays. Yeas: Commissioners Hutchinson, Engler, Jaloszynski, Horton, Moreno, Swaney and Hope. Nays: None.

E. Collective Bargaining Agreement Offer to Police Officers Association of Michigan – Corrections Unit:

It was moved by Commissioner Hope and seconded by Commissioner Jaloszynski to enter into a 3- year agreement between Isabella County Board of Commissioners and Isabella County Sheriff's Office and Police Officers Association of Michigan – Corrections Unit, agreeing that 2% shall be added to the 2020 base wage scale, effective March 16, 2021, with a wage reopener for years 2022 and 2023, and to include the language in the Employer's package offer to settled dated March 15, 2021. The motion carried with 7 yeas and 0 nays. Yeas: Commissioners Hutchinson, Engler, Jaloszynski, Horton, Moreno, Swaney and Hope. Nays: None.

Materials Recovery Facility Director Jake Borton explained the Two Percent request from his Department.

Announcements:

Commissioner Jaloszynski stated he appreciated the Financial Management plan presentation at the Work Session earlier in the day. He also stated that the public has asked why the website for the County states that the County Building is closed to the public.

Administrator/Controller Margaret McAvoy explained that the website was recently updated and that the building is open to the public by appointment. She also explained that the current recommendations from the Michigan Department of Health and Human Services is that if employees can work from home they are to still be working from home.

Commissioner Engler stated that citizens should contact MSU Extension office for information on Gypsy Moth Spraying.

Commissioner Hope stated that through the Community Mental Health Board that he attended an inservice on the Jail Diversion program.

Commissioner Hope stated that he received his second vaccination for COVID 19 and had no side effects. He is happy that the Central Michigan District Health Department seems to be so far ahead of vaccinating than other locations in the state. He encouraged everyone to get vaccinated.

Commissioner Hope congratulated the CMU Woman's Basketball Team on winning the MAC Tournament.
