VAR#19-01 - Rolland Township

Mr. Johnson explained that an application submitted by Dwight Dargitz is requesting a variance for two existing buildings to have side yard setbacks of 8 ft where 20 ft is required for a newly created parcel. The property is on Jerseyville Rd. just between S. Rolland Rd and S. Wyman Rd.

Mr. Johnson stated that Mr. Dargitz has submitted the variance request for a side yard setback reduction for two existing buildings so that he can split the property between the two buildings. Mr. Dargitz is desiring to split the property so that he can sell the larger parcel to his son. Mr. Dargitz points out that these buildings were not constructed by him and have in-fact been on the property for over 50 years.

Mr. Johnson reported that Mr. Dargitz is not constructing any new buildings or installing any new infrastructure at this time.

Dwight Dargitz reiterated his request to split the property to be able to sell the remaining property to his son.

Mark Dargitz stated he was in support of this variance request.

Board discussion took place and reviewed section 14.04 C of the ordinance. The Board found the applicant had demonstrated he was meeting all of the conditions in 14.04 C.

A motion was made by Mr. Vogel supported by Mr. Duffett to approve Variance Number 19-01 as submitted by Dwight Dargitz for two existing buildings to have side yard setbacks of 8 ft where 20 ft is required for this parcel in the Buffer Agricultural District (AG-3).


