Notice of Electronically Conducted Meeting and Public Hearing**

Notice is hereby given that the Isabella County Planning Commission will conduct its regularly scheduled November 18, 2021 Planning Commission meeting electronically at 7:00 p.m.

Following the recommendations of state and county health officials and the Center for Disease Control & Prevention in an effort to slow the spread of COVID-19, and in keeping with the County's COVID-19 Preparedness and Response Plan, the Michigan Occupational Safety and Health Administration Emergency Rules for COVID-19, and the Michigan Open Meetings Act, the November 18, 2021 Isabella County Planning Commission Meeting will not provide for in-person public attendance.

Public comment will be received during the normal public comment sections of the meeting via telephone call-in and during public hearing agenda items. **To raise your hand for public comment, telephone participants should press *9.** The host will announce the last three (3) digits of the caller's telephone number to alert the public comment participant that it is their turn to speak. The Planning Commission Chairman will call on you to speak, and your audio will be unmuted for your public comment time.

PLEASE TAKE NOTE that the Isabella County Planning Commission will conduct a public hearing on the following request:

Zoning Amendment #21-01: The Planning Commission will consider taking action on a request to rezone a piece of property from Low Density Residential (R-1) to General Commercial (C-1) submitted by Wolgast Corporation. The affected property is located in the 6100 Block of W Weidman Rd., Weidman, MI 48893. Section 13 of Sherman Township. Parcel #13-099-00-131-41, legally described as:

MONUMENTED); THENCE S 00°05'18" E, 407.01 FEET (RECORDED AS S 00°12'00"E, 407.40 FEET) ALONG THE EAST LINE OF SAID BLOCK 17 (AS MONUMENTED) TO THE POINT OF BEGINNING. INCLUDING ALL OF THE 20.00-FOOT-WIDE VACATED ALLEY IN SAID BLOCK 17, AS VACATED IN LIBER 886, PAGE 530 ISABELLA COUNTY RECORDS.
