## **LIAISON REPORTS**

Zoning Board of Appeals – None.

## **PUBLIC HEARING**

### **Map Amendment ZA#22-03 Higgins – Isabella Township**

Mr. Johnson reviewed his staff report for the application submitted by Jeff Bean to rezone a portion of property in Section 11 of Isabella Township from General Agricultural (AG-2) and Medium Density Residential (R-2) to Light Industrial (I-1).

Mr. Johnson indicated the proposal appeared to be consistent with the County Master Plan, is less than ¼ mile to existing industrial and commercial uses and it appears the site is likely able to accommodate the continuation of the existing industrial use and/or other uses allowed in the Light Industrial zoning district.

Mr. Vogel asked what uses are allowed in the Light Industrial district.

Mr. Johnson gave examples of uses from the Zoning Ordinance.

Mr. Bean invited the applicant to present their justification for the rezoning request.

Jeff Bean reviewed his narrative to the Planning Commission and focused his justification on the soils being very poor and not conducive for farming. He also indicated this property has been used for industrial purposes for many years.

Mr. Bean opened the public hearing at 7:12 p.m., closed at 7:12 p.m.

Mr. Bean called for a motion.

A motion was made by Ms. Silker to recommend approval to the County Board of Commissioners map amendment 22-03 (ZA#22-03) as submitted, to rezone a piece of property from the General Agricultural (AG-2) and Medium Density Residential (R-2) district to Light Industrial (I-1).

The motion was supported by Mr. Swaney.

Mr. Bean called for discussion.

Mr. Neyer agreed the land was not useful for agricultural purposes and noted the proposed was supported by the County Master Plan. He also indicated an industrial use on the property was compatible with neighboring uses.

Mr. Bean agreed.

Hearing no further discussion, Mr. Bean called for a vote.

## **OTHER BUSINESS (NON-PUBLIC HEARINGS)**

### **Union Township Map Amendment**

Mr. Johnson informed the Planning Commission that a map amendment was submitted by Union Township for review and comment. Mr. Johnson reviewed the Union Township Planning Commission action and justification. He informed the members that a letter would be sent back to Union Township informing them of the review with no comments or concerns.

### **PA116 – Donald and Susan Yager – Wise Township**

Mr. Johnson informed the Planning Commission that an application to the Farmland and Open Space Preservation Program (PA116) was received by the Wise Township Clerk. He indicated the property appeared to be currently used for agricultural purposes and was zoned and planned by Wise Township to be agricultural. He indicated that the application appeared to be complete with the exception of the number of years Mr. and Ms. Yager were applying for on page 3 was missing.

Mr. Johnson stated a letter would be forwarded to the Township Clerk informing them of the Planning Commission's review and missing information.

### **PA116 – Donald and Susan Yager – Denver Township**

Mr. Johnson informed the Planning Commission that three (3) applications to the Farmland and Open Space Preservation Program (PA116) was received by the County Clerk for property in Denver Township. He indicated the properties appeared to be used for agricultural purposes and the County zoned and planned for the properties to remain agricultural. He indicated that all three (3) applications appeared to be complete.

Mr. Johnson stated a letter would be forwarded to the County Clerk informing them of the Planning Commission's review of the applications.

### **Isabella County Master Plan Amendment Update**

Mr. Johnson reviewed the status of the process of updating the County Master Plan. Mr. Johnson indicated the next step was for the Planning Commission to set a public hearing for their next meeting to review comments received, receive public comments and approve the amendments to the Master Plan.

Mr. Neyer moved to set a public hearing to review comments on and approve the amendments to the Master Plan for November 10, 2022 at 7:00 p.m. He stated the public hearing would be held at the Isabella County Building at 200 N. Main St., Mt. Pleasant, Michigan.

The motion was seconded by Mr. O'Neil.

Mr. Bean called for a vote.

Mr. Nieporte confirmed written complaints from the public are accepted for potential zoning violations.


Mr. Vogel asked about the tree removal on US-127 near the northern boundary of Mt. Pleasant.
