Mr. Johnson indicated that a Special Use application in a Township where the County currently has zoning jurisdiction would be reviewed by the County Planning Commission.

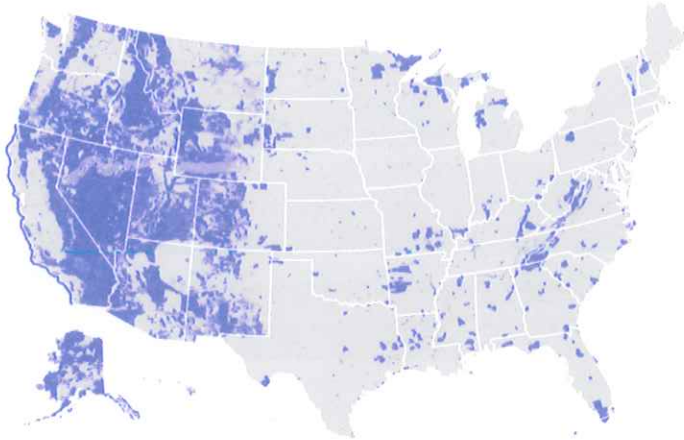
General discussion occurred on the special use permit application and approval process.
