Mt. Pleasant DPS Director Paul Lauria -

- Mount Pleasant Police Department will through countywide mental health training. This is being coordinated with Community Mental Health and Mount Pleasant City Police. This will happen in August and will also cover responses to domestic violence and sexual assault.
- Director Lauria at the request of CMLife ran a report covering the last 10 years. During COVID lockdown domestic violence skyrocketed.
 There was a drop in cases when businesses started to open. Sexual assault cases followed similar trends.
- Sherif Main also has done some work on recording and reporting domestic violence rates. Still not pre-pandemic levels.
- Electric scooters are coming to Mount Pleasant, there are some potential concerns such as traffic and safety, but the city of Mount Pleasant is taking steps to alleviate concerns.
- An electric trolly service is also coming to Mount Pleasant and will allow alcohol on board.
- Both the electric scooters and trolly are limited to 25 mph roads
