## **OTHER BUSINESS (NON-PUBLIC HEARINGS)**

### **SITE PLAN REVIEW #24-04 – Private Road, Louis Proton – Sherman Township**

Mr. Johnson reviewed his staff report and the application submitted by Tim BeBee of CMS&D and Louis Proton. He indicated that Mr. Tim BeBee provided a site plan showing the layout of the proposed private road. Additionally, the site plan details the currently developed paved driveway the applicant is proposing to use as the private road, including surface, base, subbase materials and the proposed right of way.

Mr. Johnson also indicated that staff has reviewed the site pan and it appears to meet all ordinance requirements, except those Mr. Tim Bebee is requesting the Planning Commission reduce. Staff has provided the Planning Commission with a checklist of ordinance requirements for their review, along with the two conditions the staff recommended for the approval.

1. The applicant shall provide a signed sworn statement certifying that the private road has been constructed in accordance with the requirements of Isabella County Zoning Ordinance and the Isabella County Planning Commission.
2. The applicant shall adhere to the Uniform House Numbering Ordinance for private road names and install a stop sign, road name sign private road sign and provide a copy of a

recorded road maintenance agreement in accordance with the Isabella County Zoning Ordinance.

Mrs. Silker asked if the person who owns the home next to this property had questions regarding the private road.

Mr. Johnson stated that the house is also owned by applicant.

Mr. Vogel asked if the property was sold what would be the future use of the parcel.

Mr. Johnson stated that future use is unclear but it has been industrial property for a little over 15 years.

Mr. Swaney asked if having a private road approval come through the Planning Commission is a standard practice.

Mr. Johnson stated that more uncommon with Industrial Districts but more common with Agricultural Districts.

Mr. Brookens asked why there was a residence in an Industrial District.

Mr. Johnson stated that the residence was existing in 2016 before the Sherman Township repealed their zoning ordinance.

Mr. Bean asked who will be doing the road maintenance for the private road.

Mr. Johnson stated that applicant is required by ordinance to record and provide a copy of a road maintenance agreement for both parcels.

Mr. Bean questioned a need for a variance. He indicated it wouldn't make sense to tear up the road if they meet the requirements including those reduced by the Planning Commission.

Mr. O'Neil called for a motion.

A motion was made by Mrs. Silker to approve Site Plan Review #24-04 (SPR#24-04) as submitted by Tim BeBee on behalf of Louis Proton for a private road to service 2 parcels in the Light Industrial (I-1) district. The approval shall further be conditioned upon the following:

1. The applicant shall provide a signed sworn statement certifying that the private road has been constructed in accordance with the requirements of Isabella County Zoning Ordinance and the Isabella County Planning Commission.
2. The applicant shall adhere to the Uniform House Numbering Ordinance for private road names and install a stop sign, road name sign private road sign and provide a copy of a

The motion was seconded by Mr. Swaney.

Mr. Bean called for further discussion.
