- 1. It was moved by Commissioner Weber and seconded by Commissioner Jaloszynski to ratify and place on file the June 13, 2025 Invoice List in the amount of \$256,329.79; the June 20, 2025 Invoice List in the amount of \$210,309.64; the June 27, 2025 Invoice List in the amount of \$415,406.54; Adjustments List dated June 12, 2025; and the Adjustments List dated June 26, 2025. - 2. It was moved by Commissioner Hope and seconded by Commissioner Weber to approve the Fiscal Year 2026 Victim Rights Prosecutor Grant Application and authorize the Prosecuting Attorney to sign the same in Egrams. Motion carried with Yeas: Commissioners Hope, Engler, Campbell, Weber and Jaloszynski. Nays: None.
- 3. It was moved by Commissioner Campbell and seconded by Commissioner Jaloszynski to approve the Michigan Public Safety Communications Systems (MPSCS) member credit offer in the amount of \$129,173.00, as well as Resolution 2025-07 as required by MPSCS, and authorize the Board Chairperson to sign the same. It was moved by Commissioner Jaloszynski and seconded by Commissioner Hope to approve the Central Square OneSolution Quote in an amount of \$129,038.62 and authorize the Board Chairperson to sign the same. Motion carried with Yeas: Commissioners Hope, Engler, Campbell, Weber and Jaloszynski. Nays: None.

- 5. It was moved by Commissioner Weber and seconded by Commissioner Hope to approve the FY24 Homeland Security Grant Program Intergovernmental Agreement (HSGP) between the West Michigan Regional Medical Consortium and Isabella County Emergency Management, and authorize the Board Chairperson to sign the same. Motion carried with Yeas: Commissioners Hope, Engler, Campbell, Weber and Jaloszynski. Nays: None.
- 6. It was moved by Commissioner Hope and seconded by Commissioner Jaloszynski to approve the Addition of 2 FTE Positions to the approved staffing list within the Corrections Department, which would equate to up to 4 part-time, not eligible for employer benefits, positions to serve as on-call transport roles. It was moved by Commissioner Campbell and seconded by Commissioner Jaloszynski to approve the initial Purchase of the Bobcat G33 Fork Truck in the amount of \$34,391.00 using 2% funds and then submitting for reimbursement under the terms of the contract with the Saginaw Chippewa Indian Tribe regarding the EPA Infrastructure grant, and ask the Board Chairperson to sign the same. Recycling Director Jake Borton was present to review and answer questions. Motion carried with Yeas: Commissioners Hope, Engler, Campbell, Weber and Jaloszynski. Nays: None.
- 8. It was moved by Commissioner Jaloszynski and seconded by Commissioner Hope to approve the Grant Agreement from the Mt. Pleasant Area Community Foundation accepting funds for 10 to 12 small counter top bio digesters, in the amount of \$5,000.00, and authorize the Board Chairperson to sign the same. Recycling Director Jake Borton and Helen Lee Education/Grant Writing and Coordinator. Motion carried with Yeas: Commissioners Hope, Engler, Campbell, Weber and Jaloszynski. Nays: None.

- 9. It was moved by Commissioner Weber and seconded by Commissioner Jaloszynski to approve the Grant Agreement from the Mt.
