- B. It was moved by Commissioner Jaloszynski and seconded by Commissioner Moreno to nominate Anna Winters for one opening on the Opioid Advisory Committee, At- Large, representing a provider of opioid substance use disorder recovery support services for an initial term ending December 31, 2028, or until a successor is appointed. Chairman Engler called for nominations three times. It was moved by Commissioner Hope and seconded by Commissioner Jaloszynski to close nominations and cast a unanimous ballot for Anna Winters. Motion carried.

It was moved by Commissioner Hope and seconded by Commissioner Jaloszynski to approve the FY26 Swift and Sure Sanctions Probation Program Grant Contract, in the amount of \$83,277, and authorize the Court Administrator to utilize DocuSign to sign the same. Motion carried with Yeas: Commissioners Hope, Moreno, Engler, Swaney, Jaloszynski, Campbell and Weber. Nays: None.
- 3. It was moved by Commissioner Campbell and seconded by Commissioner Moreno to approve the FY26 Adult DWI/Drug Court Grant Contract, in the amount of \$122,880, and authorize the Court Administrator to utilize DocuSign to sign the same. It was moved by Commissioner Moreno and seconded by Commissioner Weber to approve the FY26 Juvenile Drug Court Grant Contract, in the amount of \$104,448, and authorize the Court Administrator to utilize DocuSign to sign the same. It was moved by Commissioner Jaloszynski and seconded by Commissioner Hope to approve the Remer Plumbing Quote to replace three (3) boilers at the Commission on Aging, at a cost of \$23,908 per boiler, and approve Budget Amendment 2026-04BOC, and authorize the Board Chairperson to sign the same. This request came in as an emergency, so it did have to go out for bids according to the purchasing policy.
