HEARING TO AMEND LAKE LEVEL ORDER

A petition dated November 21, 2025, was filed with the Isabella County Circuit Court to amend the lake level order for Weidman Mill Pond located in Nottawa Township and Sherman Township, Isabella County, Michigan. The Isabella County Circuit Court will review the petition on the date, time, and location below to receive evidence to amend the lake level order consistent with the provisions of MCL 324.30707.

HEARING PARTICIPATION

Property owners may submit written testimony and/or evidence regarding the petition and this matter in advance of the Circuit Court hearing. Property owners may also attend the Circuit Court hearing in-person on the above date, time, and location to provide oral testimony and/or evidence to the Court.

All property owners who wish to provide testimony and/or evidence are requested to submit a completed testimony registration form, a copy of which is enclosed and is also posted at <https://www.isabellacounty.org/>.

Because it is anticipated that a significant number of property owners may wish to attend the hearing and/or provide testimony and evidence, the Court will use the completed testimony registration forms to determine how much time for testimony is available. Please note that time for oral testimony and/or evidence during the hearing may be limited. HEARING TO AMEND LAKE LEVEL ORDER WEIDMAN MILL POND

Why am I receiving this notice?

You are receiving this notice because you own lands within the historical or proposed lake level special assessment district for Weidman Mill Pond.

What is a legally established lake level?

Part 307 of Michigan's Natural Resources and Environmental Protection Act allows circuit courts to establish lake levels for inland lakes to, among other things, benefit property owners and preserve Michigan's natural resources. Weidman Mill Pond has a court ordered lake level under Part 307.

What is a special assessment district?

A special assessment district is an area of land designated to receive special assessments for a particular benefit received from certain public projects, like lake levels.

Why is the lake level order being amended?

The Isabella County Drain Commissioner initiated a project to repair/reconstruct a portion of the Weidman Mill Pond Dam. As part of the project, the Drain Commissioner reviewed the historical lake level order and found that updates are necessary to be consistent with state law and the planned operation of the Dam. Specifically, the proposed amendments would:

- Update the legal lake level in the order to match the physical level that has been historically maintained
- Clarify the survey datum used to measure the lake level as the North American Vertical Datum of 1988 (NAVD88)

- Clarify that the lake level is subject to temporary variations due to things like weather and natural conditions

The amendments would also confirm the boundaries of a special assessment district to fund operation and maintenance of the legal lake level.

How will this impact the level of Weidman Mill Pond?

The intent of the proposed amendments is **not** to impact the physical lake level that property owners are used to seeing on Weidman Mill Pond.

What is my assessment amount?

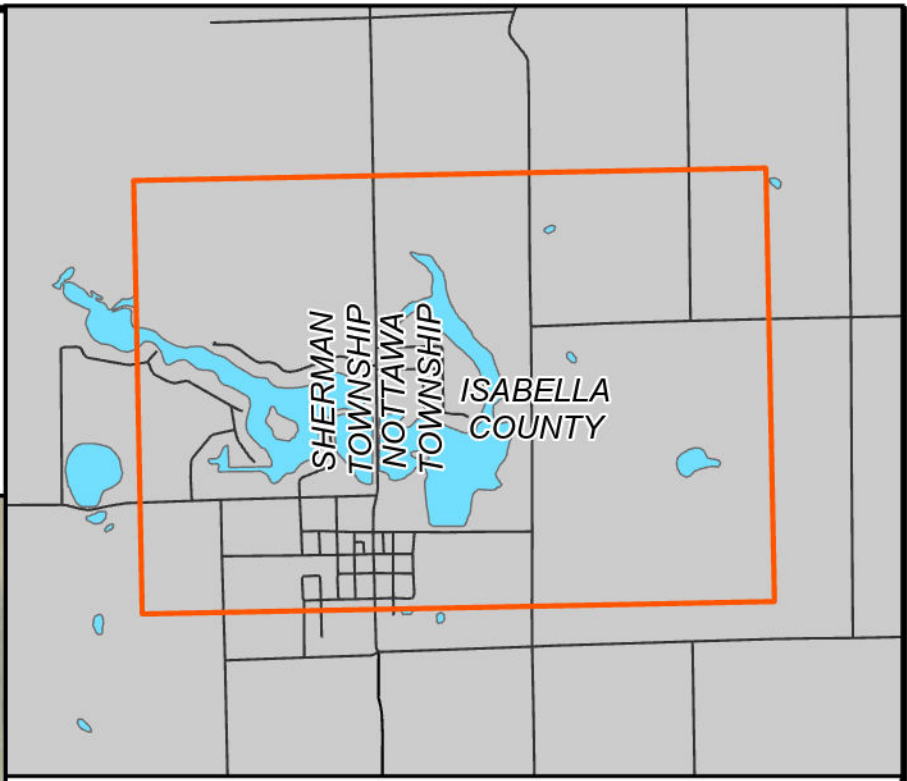
The court hearing to amend the lake level order will **not** consider special assessments. A separate public hearing process is required to impose any lake level special assessments, and all property owners will be mailed notice of the hearing. Isabella County has also received 2% funding to help offset the amount of any potential assessments.

Do I have to attend the Circuit Court hearing?

You are **not** required to attend the Circuit Court hearing; however, it is your right to do so. You may also present testimony and evidence to the Court regarding the proposed lake level order amendments. All property owners who wish to provide testimony and/or evidence are requested to submit a completed testimony registration form by **February 16, 2026**, a copy of which is enclosed and is also posted at **<https://www.isabellacounty.org/>**.
