SENIOR CITIZENS SERVICES MILLAGE RENEWAL PROPOSAL

For the purpose of continuing funding of services and activities for older persons within Isabella County, including planning, coordinating, and funding the continuation of the Isabella County Commission on Aging services and programming at the same rate approved by the voters in 2016, shall the previously approved millage be renewed by up to 1.00 mill (\$1.00 per \$1,000 of Taxable Value) for a period of ten (10) years (2026-2035) inclusive?

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation allowance and renews millage that will expire with the 2026 tax levy.

Shall the currently authorized millage rate limitation of 18 mills (\$18.00 on each \$1,000 of taxable valuation) on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Clare Public Schools, Clare and Isabella Counties, Michigan, be renewed for a period of 10 years, 2027 to 2036, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and levied in 2027 is approximately \$2,892,772 (this is a renewal of millage that will expire with the 2026 tax levy)?
