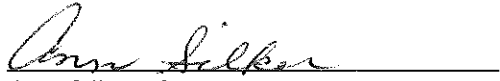
Mr. Johnson stated that the updated ordinance was passed out prior to the meeting. He indicated this includes all amendments to date.
